FISED is a non-profit federation, that extends its operative area from the Voluntary Sector to the Social Affairs. It concerns about legality, charity, and education, paying particular attention to those who are usually forgotten.

The federation is firmly rooted in Christian values and its main purpose is to promote and develop different social-welfare activities and services to improve people's lives. To reach the goal faster and in a more effective way, FISED wants to work with all the other local operators of the third sector, by gathering them in the same action network.

ASSOCIATES' BENEFITS

FISED offers various services to its registered members:

- 1. **"FISED RISPONDE"- Consultancy regarding legal, tax and administration area.** Affiliates will always be informed about tax and legal news by the national secretariat, which will refer to the specialized consultants of the federation to give the best answer in the shortest time.
- 2. Membership, accounting, statutory tax breaks and regulatory simplification for social promotion associations, volunteer organizations and amateur sports associations.
- 3. Registration to RUNTS Single National Third Sector Register and other registers. These are required to verify the statute and the articles of the various associations operating in the realm of social activity and to qualify them as Third Sector Entities (ETS). The federation will help the affiliates to subscribe to the registers needed, providing the required documents and devices, such as financial statements and registries of volunteers. It will also assist the drafting of the Statute and the articles of incorporation.
- **4. Insurance coverage.** It provides a secure protection in the event of an accident or illness for the members of the affiliated associations. Third party insurance for each member is also taken out by FISED.
- 5. **Universal Civil Service**. Promoted by the European Union (EU), the project aims to encourage the individual and professional development of young people and their acquisition of skills, through non-formal learning experiences. This opportunity is given by the Italian Prime Minister's Office to those who are between 18 and 29 years old and provides a monthly economic compensation.
- 6. **National exposure.** FISED will guarantee its associates national visibility on its social media channels, local deputations for projects and events organized by the other affiliates and active participation to the various activities that the federation will organize nationwide.
- 7. "SPORTELLO DELLA SOLIDARIETA'" Tax assistance center (CAF) and other charitable institutions. This service was created for the purpose of encouraging and supporting the accomplishment of local social projects based on the values of solidarity, mutual aid, social inclusion, and the promotion of underprivileged groups.
- **8. Training courses.** Managers, supervisors, volunteers, and operators can all attend useful and interesting workshops and courses aimed to approach the voluntary sector.
- 9. **Partnerships.** Over the years, the federation has consolidated strong partnerships with numerous institutions and organizations. Among these agreements are worth mentioning the ones with the Pharmaceutical Bank, the Charitable foundation "Banco Opere di Carità", and the UP Tour Agency.
- 10. **Fundraising**. Assistance in searching the most suitable financial aids private or public as well as in all related issues for activating them. FISED assists his affiliates in designing and developing projects to raise funds to support their activities and increase their sponsors.
